# All Star Quilters' Guild General Meeting Minutes

All Star Quilters' Guild General Meeting Minutes September 21, 2020

The meeting was called to order by President Kathi Thompson at 10:59 AM. The meeting was held via Zoom.

Approval of the minutes was postponed because there was not a quorum present at the meeting.

In Ellen Cannon's absence, Elaine Brett gave the Treasurer's report. There was no activity in September. Betty Ann Agnew noted that the printed and manually altered report distributed by Ellen would not be acceptable for audit purposes. Kathi will work with Ellen to get a clean printed report.

## Vicki Zoller

- Vicki said both the Challenge and the Library are on hold for now.

## Mindy Ashby

- Community Service will have a drive-by at the church on Monday, September 28, from 10-11 a.m. Food Bank donations and completed Community Service quilts will be accepted.
- Community Service quilts need to have a label attached. The blank for a name is not needed on labels of Christmas quilts for HartFelt.
- Mindy can cut batting for community service quilts and have it ready for pick up on Monday. Contact her ahead of time, preferably by email, with size needed.
- Betty Ann Agnew is doing quilting on all community service quilts and Quilts of Valor.

## Pat D'Elia

- Ways & Means has all of the blocks for the Christmas One Quilt. Pat will be working with Mindy soon to lay it out and put it together. The plan is to enter it in QuiltFest in May 2021. It will be raffled afterwards.
- The 12 x 12 group that meets at the church is continuing to meet in person. The other 12 x 12 group is not meeting.

## Barb Nichols and Linda Marsh

- Five Quilts of Valor presentations have been done recently.
- Barb and Linda will be accepting Quilts of Valor at the drive-by on Monday.

## Linda Wilson

- QuiltFest is scheduled to be held in May 2021. This is subject to change if warranted by the pandemic.
- A virtual quilt show was discussed and determined not to be a promising idea.
- An in-person show may need to be smaller. The number of entries can be limited. Attendance will need to follow local government guidelines.

## Betty Ann Agnew

- Betty Ann and Lisa Anderson, Membership Chair, and making plans to get early renewal forms out in October for return in November and December.

Pris Roehm

- Pris send out a survey to gauge interest in online classes. Only 25 members have so far responded. Global Quilt Connection still seems to be the best option for this.
- The last clue for Sunnie Malesky's Mystery Quilt class was sent out this morning. Sunnie is willing to do another mystery class if there is interest.
- The Board may be trying out virtual demos at their next meeting to determine if Demo Day can proceed online
- The Nominating Committee consisting of Pris, Teri Chamberlain, and Mindy Ashby, presented the following slate of officers: President Pat D'Elia; Vice President Linda Wilson; Treasurer Ellen Ford; Recording Secretary Linda Marsh; Corresponding Secretary Elain Brett. The slate will be published in the October newsletter. Nominations from the floor will be open at the October general meeting. Voting will be done immediately afterwards by the Telephone Committee.
- Betty Ann Agnew questioned why she and Lisa Anderson were not on the Nominating Committee's slate of officers. Betty Ann and Lisa had volunteered for President and Vice President, respectively. Betty Ann understood that anyone who volunteers must be placed on the slate. There was considerable discussion. Most attending did not understand this to be true. It was noted that past practice of the guild has been to present only a single nominee for each office to avoid competition between members. It was also pointed out that nominations from the floor may be made at the October meeting. Betty Ann and Lisa may get their names on the ballot at this time.

Kathi is still hoping to have an in-person meeting in December. Several members said they probably would not attend unless the pandemic situation improved markedly.

The meeting was adjourned at approximately 11:42 AM.

Due to the unusual circumstances caused by COVID, and not having in-person General Meetings, we want to ensure everyone has an opportunity to be part of the election. Election of Officers for 2021 is to be held October 19.

The Nominating Committee, which consists of Pris Roehm, Mindy Ashby and Terri Chamberlain, presented the following slate of officers for 2021 at the September General Guild meeting:

President – Pat D’Elia  
Vice President – Linda Wilson  
Recording Secretary – Linda Marsh  
Treasurer – Ellen Ford  
Corresponding Secretary – Elaine Brett

To prepare a proper ballot for the membership to vote, **if you are intending to make a nomination “from the floor”** (see Art. IX, Sect. C, 2b) we are asking you to contact the chairman by **Saturday October 10** with the name of the nominee and the two seconds.

The week before the election, a ballot will be emailed to each member. Ballots will have instructions to return your vote by email to the chairman of the nominating committee so they may be tallied (Art. IX, Sect. C, 2e). Those who do not have email will receive a phone call. If you want to vote, please watch your email the week of October 12 for your ballot. The deadline for getting your vote in will be midnight Monday, October 19.

## 2. Nominating Committee

Shall be appointed by the Board of Directors at the Board of Directors Meeting in August. It shall be composed of a chairperson and two members. Its duties shall be:

- To prepare a proposed slate of officers which shall be presented at the general membership meeting in September and published in the October issue of the Guild’s newsletter. No one may be nominated without his/her consent.

b. Nominations from the floor may be made at the October annual meeting. In order to be nominated from the floor, the nominee must be present or have given his/her prior written consent for the nomination to be made. Each nomination must have two seconds.

c. Any member may be nominated for office unless he/she at time of installment will hold office in another quilt guild.

d. Incumbents may not serve more than two consecutive terms in the same office.

e. Shall prepare and tally the ballots.

## **ARTICLE X – ELECTION OF OFFICERS**

Section A. Election of officers shall take place during the Annual Meeting in October.

Section B. Officers shall be elected by ballot. In the event there is only one candidate for each office, officers may be elected viva voce.

Section C. Officers shall be elected for a term of one year or until their successors are elected. Their term of office shall begin at the close of the January general meeting.

Section D. To ensure an orderly transfer of office, at least one meeting shall be held between newly elected officers and their counterparts presently in office. Newly elected officers shall attend all Board of Directors meetings that occur between the time of their election and installation.
