### **MENSTRUAL EQUITY**

For one in four Florida teens, period product access is a regular hardship, and the significant impacts of this lack of access are often overlooked. In Florida, 85% of female students in public school grades 7-12 attend Title 1 schools. To ensure that period poverty does not impede a girl's ability to attend and participate fully in school and life, menstrual equity is a must. Florida has made some progress on this front by waiving the sales tax on period supplies; however, there is important additional work to do such as providing free menstrual product access in schools, just like we do for toilet paper – another basic human need. ## E-Blasts and Email Process:

There seems to be some confusion on emails and e-blasts and what the process is for both. The process for e-blasts are as follows:

- Send email to Betty Ann (bettyaagnew@comcast.net)
- Text or call Betty Ann that a blast has been sent for distribution
- If there is no response to the text, call or blast – call Betty Ann
- o When Betty Ann sends the blast out, she always sends a “Done” or Sent” back to the originator.
- o There is no way for Betty Ann to know that someone does not receive a blast or email unless Betty Ann is notified.
- o The best way to know something is amiss - if someone DOES NOT receive a newsletter each month. Betty Ann should be notified. If the member does not notify Betty Ann for months, they have probably missed an e-blast or two.

If there is an issue with emails or blasts, please notify Betty Ann. The issue will be researched, and a solution found.

Be sure to put an "A" in the middle of the address bettyaagnew@comcast.net. In the past members have had issues with me not getting their emails because the "A" in the middle was left out. There is a bettyagnew at comcast. Unfortunately, she does not forward emails to me. I am in contact with Lisa on any changes in information. As well Lisa notifies me of changes.

## Quilt Fest

**QUILTFEST 2020**  
**“2020 Is Sew Perfect”**  
**2020 SHOW POSTPONED UNTIL MAY 2021**

As reported last month, because of the corona virus, and the uncertainty surrounding its effects and when it will be safe once again to assemble in large groups, the QuiltFest Board has voted to postpone this year’s QuiltFest. The new dates for the show are Thursday, May 13 through Saturday, May 15, and even though the show will take place in 2021, the theme will remain “2020 Is Sew Perfect.”

In addition, the QuiltFest Board has voted to move QuiltFest permanently to the end of March. The purpose for the change is (1) to move the show out of hurricane season (two of the last four shows have been affected in some way by storms), and (2) to make the show available to snowbirds before they head back to their homes up north. In 2022, the show will take place from March 31 through April 2.

Pat D’Elia will join the QuiltFest board as a representative from All Stars, effective immediately.

More information on the 2021 show and other QuiltFest decisions will be available as they are addressed by the board. In the meantime, stay safe, and keep on quilting,
